Located in beautiful Koke'e State Park, Camp Sloggett is a rustic and peaceful spot that offers hiking trails, streams, rare vegetation, and wildlife. The Lodge was built in 1925 by Henry and Etta Sloggett as a family retreat. The Sloggett children generously donated the buildings and leasehold to YWCA Kaua'i in 1938. In 1993, the Lodge was put on the Register of National Historic Sites.

The camp continues to be the first choice of many local, state, mainland, and international groups that provide youth and family, church, school, and community retreats and programming.

DOMESTIC VIOLENCE AND SEXUAL ASSAULT SERVICES

24 HOUR HOTLINE



Our 24/7/365 confidential hotline, (808) 245-6362, is supported by specially trained staff who can assist with requests for YWCA services, reporting, medical treatment, general questions and referrals related to domestic violence and sexual assault. Crisis Intervention Specialists are available 24/7 for face-to-face intervention, advocacy, and counseling.

WEB CHAT & TEXT SUPPORT SERVICES



Making a phone call to a support line or leaving the house is not always possible when you are experiencing abuse. For many, an online chat might feel more comfortable than a phone call or meeting with an advocate in person.

FAMILY VIOLENCE SHELTER



YWCA Kaua'i's shelter offers safety and services for all survivors, regardless of gender or sexual orientation. These services include: room and board, counseling, 24-hour crisis advocacy, housing support, and advocacy for children.

The location and all services offered by the shelter are free and confidential

TEMPORARY RESTRAINING ORDERS



Assistance is available for those seeking legal protection from abusive partners or family members. Our TRO Advocate will assist you with completing and filing a restraining order as well as providing emotional support and accompaniment to court.

COUNSELING SERVICES



The trauma of sexual assault/abuse can have lasting impacts on individuals and families. Our highly qualified staff use evidence-based practice to help develop the skills necessary to heal and maintain healthy relationships.



VICTIM AND FAMILY ADVOCACY



YWCA Kaua'i's Crisis Intervention Services offers 24/7 support and advocacy for survivors and their families. Advocacy services include face-to-face crisis counseling and support before, during, and after medical forensic exams, reports to law enforcement, legal consultations, and court appearances.

Police reporting is not a requirement for receiving services or a forensic medical exam (also known as a "sexual assault nurse exam").

PREVENTION EDUCATION



YWCA Kaua'i offers Sexual Assault Prevention Education to all schools and service providers. The delivery of this evidence-based curricula is offered free of charge with the goal of creating safter spaces, minimizing stigma, and preventing sexual violence. Age-appropriate instruction is offered to students pre-school through 12th grade.

Training for businesses, agencies, and groups regarding the dynamics of sexual assault is also available.

OFFENDER SERVICES

SEX OFFENDER TREATMENT



The YWCA Sex Offender Treatment Program works with court-referred adult sex offenders. and youth with sexual behavior problems. Services include psychosexual assessment and evaluation (including polygraph tests). individual, family, and group counseling sessions, and referrals for additional treatment.

ALTERNATIVES TO VIOLENCE



A batterer intervention program with the goal of keeping victims safe and providing a means for abusive partners to start on the path of truly changing their abusive behavior.
